

Fund Report (Sep 2024)

Important note:

- 1.BU China Gateway Fund ("the Fund") is a sub-fund of BU Investment Series OFC ("the Company"), which is a public open-ended fund company ("OFC") (business registration number 72687438) regulated under the laws of Hong Kong, with variable capital and limited liability and segregated liability between sub-funds.
- 2.The Fund seeks medium to long term capital growth and income through investing primarily in equity securities and/or debt securities, that are either (a) traded in China or (b) issued by entities incorporated in China or entities which have significant operations in or assets in, or derive significant portion of revenue or profits from China.

Bracing for possible market pullbacks as US election, unwinding yen carry trades induce volatility

Market Review and Outlook

After a volatile start in early August, the MSCI China Index (USD) ended relatively flat from the previous month. Early on, global markets tumbled after a bout of weak US economic data reignited investor concerns about a potential hard landing. The sell-off was further exacerbated by the unwinding of JPY carry trades, but calm was restored as investors returned for bargain hunting.

China's economic recovery remained uneven. July imports surpassed estimates but exports lagged. Retail sales rose 2.7%, slightly exceeding forecasts, but sales declined in major cities including Beijing and Shanghai. Furthermore, January-July fixed asset investment missed forecasts. We will continue to evaluate China's recovery trajectory.





We stay focused on dividend and value plays, as the central government encourages listed companies to enhance shareholder returns through share buybacks or dividend pay-outs. Despite sluggish domestic consumption, we still favour cash-rich Chinese e-commerce and internet giants, many of which are actively repurchasing their shares.

We uphold our preference towards market leaders with strong balance sheet and free cash flow, with the potential for capital management and company specific catalysts. Other dividend plays we are attracted to include telecommunications providers, energy producers, and leading banks and insurance companies.

With the semiconductor cycle bottoming out, we stay optimistic on tech leaders with structural growth prospects. The emergence of AI as a multi-year theme, significantly supports the growth of the tech sector. But our teams are mindful of potential AI-driven pullbacks, as market volatility could pick up ahead of the US election and in light of further unwinding of yen carry trades.

In August, the spreads of China's investment-grade bonds remained relatively stable. Second-quarter earnings of China's technology, media and telecommunications companies broadly met market expectations, and several major players saw their ratings being upgraded on improved profitability and stronger credit fundamentals. Into September, spreads may face pressure and rising volatility as the US election approaches and uncertainties surrounding the magnitude of rate cut. We expect that favourable technical factors, such as limited supply, rate cut expectations and idiosyncratic corporate actions, will continue to lend support to Chinese investment-grade bonds.

Investment Strategy

Our teams continue to favour China's dividend and value stocks across various sectors including information technology, telecommunications, and energy. Energy stocks, in particular, offer a hedge against rising geopolitical tensions that could drive market volatility.

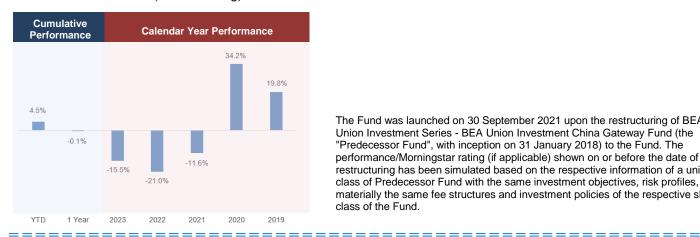
The Fund upholds a positive stance on the IT sector, buoyed by the bottoming out of the semiconductor cycle as well as growing AI applications. We continue to see opportunities among Taiwanese and US tech leaders but are bracing ourselves against potential pullbacks, given the sector's substantial rally this year.

Regarding fixed income, our teams remain constructive towards China's TMT Investment-grade bonds due to their strong cash flow and robust credit fundamentals.
